Notice inviting Tenders (NIT) are invited in Single Bid from interested contractors who fulfil the eligibility criteria provided below for **“Renovation of Brahmaputra Lab at Physics Department, CU”**

1. General Terms and Conditions:

The applicant should meet the following minimum terms and conditions and criteria:-

- 1.1 There will be **Tender fee (non-refundable)** of an amount of **Rs. 500.00 (Rupees Five hundred only)** to be submitted in the form of Demand draft in favour of “The Registrar, Cotton University” payable at Guwahati along with the tender documents.
- 1.2 The tenderers should be registered in APWD (Buildings) not more than Class-I (C) category.
- 1.3 Average Annual turnover in last 3 (three) years should be at least Rs.2 lakhs
- 1.4 Copy of income tax return for the last three consecutive years to be submitted.
- 1.5 The tenderer shall submit copies of PAN Card, GST registration Certificate.
- 1.6 The Original tender copy marked duly completed and signed on each page should be submitted along with the offer.
- 1.7 The tender is single bid and therefore should be placed in single sealed covers super-scribing the full name of the work .The full name, postal address of the tenderer shall be written on the bottom left corner of the sealed cover.
- 1.8 The bidding document may be downloaded from **University Website** or may be collected from **Engineering Cell, CU**
- 1.9 **Non-conformity** of any of the terms and conditions along with non-submission of any of the documents mentioned above **will disqualify** the tenderer.

All disputes in this connection shall be settled in **Kamrup Metropolitan district jurisdiction** only.
